



PADRE AYALA and BEATO LUIS BELDA ACdP SCHOLARSHIPS

Academic year 2023-2024

BASIS FOR THE CONCESSION.

The Catholic Association of Propagandists announces the scholarships *ACdP Father Angel Ayala*, and *ACdP Blessed Luis Belda*, to study a Bachelor's degree in Humanities, and in History or Art History at Universidad San Pablo CEU, during the academic year 2023- 2024.

1.- Target group: Students who wish to study for a Bachelor's degree in Humanities, History or Art History at Universidad San Pablo CEU for the 2023-2024 academic year.

2.- Number and Amount - Only 2 scholarships are offered: one for the Bachelor's degree in Humanities, and the other for the Bachelor's degree in History or Art History. Each scholarship will be equal to 90% of the total costs that, coming from the University, generated exclusively by the completion of one of these three Bachelor's degrees - Humanities, History or Art History - and not those that have to do with a possible second degree to be studied together with one of the three mentioned, or additional services such as transportation, accommodation or meals. In the event that a student enrolls in two of these three degrees at the same time, particularly History and Art History, it will be up to the student to choose which of them he/she wants to receive the aid.

3.- Criteria for awarding the scholarship: Criteria for awarding the scholarship will take into account both academic and economic excellence, as well as those related to the candidate's humanistic vocation, and the result of a personal interview with the applicant.

In any case, it will be necessary to have a good academic record, with an average of no less than 7 out of 10.

4.- Effectiveness requirement: In order for the scholarship to be effective, it will be necessary to enroll in at least 60 ECTS per year. Such enrollment must be made within 5 days following the publication of the grades corresponding to the EVAU - University Entrance Examination -. In the case of double degrees taken simultaneously, the aid will be proportional to the number of credits enrolled in the degree being aided.



5.- Form of payment - As established by Universidad San Pablo CEU.

6.- Incompatibility. These scholarships are incompatible with any other private scholarship granted for the same purpose, which would generate the need for a proportional return of the scholarship granted by the ACdP.

The student benefiting from the ACdP scholarships will be obliged to communicate all aid received from other institutions for the realization of these same university studies.

The same obligation of proportional repayment of the aid received in the current academic year shall apply in the event of abandonment of studies.

7.- Obligations of the beneficiary. The beneficiaries of the scholarships must collaborate with the Catholic Association of Propagandists in carrying out a series of tasks related to the purposes of the Association, which will be specified at the time. For this purpose, a tutor will be assigned to them.

8.- Renewal. In order to renew the scholarship it will be necessary to obtain an average grade equal to or higher than 7 points, having passed all the credits enrolled according to the 4th base.

10.- Deadlines and procedures

The application must be submitted to the Secretariat of the Catholic Association of Propagandists by e-mail (**acd@acd.es**), with a deadline of **May 26, 2023**. The applications will be resolved by a commission appointed by the National Council of the ACdP and will be communicated no later than **June 9 of the same year**.
