Father Ayala and Blessed Luis Belda ACdP Scholarships

ACADEMIC YEAR 2024 - 2025



The Catholic Association of Propagandists announces the scholarships *ACdP Father Ángel Ayala*, and *ACdP Blessed Luis Belda*, to study the Bachelor's degree in Humanities, and in History or Art History at Universidad San Pablo CEU, during the academic year 2024-2025.

1.- Addressees

Students wishing to study for a degree in Humanities, History or Art History at Universidad San Pablo CEU, for the 2024-2025 academic year.

Number of Scholarships and Worth

Only 2 scholarships are available: one for the Bachelor's degree in Humanities, and the other one for the Bachelor's degree in History or Art History. Each scholarship will be equal to 90% of the total expenses that, coming from the University, generated exclusively by the completion of one of these three degrees - Humanities, History or History of Art - and not those related to a possible second degree to be studied together with one of the three mentioned, or additional services such as transportation, accommodation or meals. In the event that a student enrolls in two of these three degrees at the same time, particularly History and Art History, it will be up to the student to choose which of them he/she wants to receive the aid.

3.- Awarding criteria

For the awarding of the scholarship, both academic and economic excellence criteria will be considered, as well as those related to the candidate's humanistic vocation, and the result of a personal interview with the applicant.

In any case, it will be necessary to have a good academic record, with an average of no less than 7 out of 10.

4.- Effectiveness requirement

For the effectiveness of the scholarship, it will be necessary to enroll in at least 60 ECTS per course. Such enrollment must be made within 5 days following the publication of the grades corresponding to the EVAU - University Entrance Examination -. In the case of double degrees taken simultaneously, the aid will be proportional to the number of credits enrolled in the degree being aided.

5.- Form of payment

The one established by Universidad San Pablo CEU.

6.- Incompatibility

These scholarships are incompatible with any other private scholarship granted for the same purpose, which would generate the need for a proportional return of the scholarship granted by the ACdP.

The student benefiting from the ACdP scholarships will be obliged to communicate all aid received from other institutions for the realization of these same university studies.

The same obligation of proportional repayment of the aid received in the current academic year shall apply in the event of abandonment of studies.

Obligations of the beneficiary

The beneficiaries of the scholarships must collaborate with the Catholic Association of Propagandists in carrying out a series of tasks related to the aims of the Association, which will be specified in due course. A tutor will be assigned to them for this purpose.

8.- Renewal

In order to renew the scholarship it will be necessary to obtain an average grade equal to or higher than 7 points, having passed all the credits enrolled according to the 4th term.

9.- Documentation to be submitted

- Documentation related to the previous academic record; 1st and 2nd year of Baccalaureate.
- Income tax return corresponding to the fiscal year 2023 of all the members of the family unit.
- Motivation letter.
- Any other documentation that the candidate considers appropriate for this purpose.

10.- Deadlines and procedures

The scholarship must be applied for until **June 10, 2024**. The applications will be decided by a commission appointed by the National Council of the ACdP and will be communicated **on June 20 of the same year**.
