3. COURSE DESCRIPTION

This subject focuses on identifying and assessing the role of Spain and the European Union in the global scene.

It analyses the external relations of Spain and the European Union from an interdisciplinary perspective, taking into account its priorities and main challenges.

4. COMPETENCES

Activity	Definition
Lecture (AF1)	Learning activity that takes place in the classroom and focuses on the transmission of knowledge by the professor, requiring the student to prepare and / or study afterwards.
Seminar (AF2)	Learning activity that takes place in the classroom and, under the guidance of the professor, encourages cooperative learning among the students. Its objective is the study and understanding the subject.



Working group (AF3)	Learning activity that takes place in the classroom and, under the guidance of the professor, aims to resolve practical cases or to deepen the students' knowledge in a concrete area of special interest.

6. ASSESMENT

1. CLASS ATTENDANCE:

Regular and punctual class attendance is expected of all students.

A 75 % minimum attendance requirement applies. It is indispensable for continuous assessment. As there is a 25 % margin for non - attendance, in general circumstances, certificates that justify absences from class, even for valid reasons, are not to be accepted.
