The course focuses on both Private and Public Restraints to competition in Europe, including the control of collusion and abuses of a dominant position, merger control, state aids, the granting of exclusive or special rights and other public restraints..

The main aims are:

- b) to assimilate the fundamental principles of EU Competition Law, in particular control of collusion and abuses of a dominant position, merger control, state aids, the granting of exclusive or special rights and other public restraints.
- c) To get used to a fluent reading and analysis of the Commission's and Court of Justice's case law regarding these issues.
- d) To learn how to solve hypothetical cases related to these issues.

# 5. TEACHING METHODOLOGY OF THE COURSE

#### **LEARNING ACTIVITIES**

### 1. - LECTURE (AF1):

Along the semester, six lectures will systematically introduce the student to each of the blocks of the program, offering an overview and their main keys. In particular, the 6 lectures will devoted to:

- L1: Concept and development of EU Competition Law: Aims, evolution and achievements.
- L2: Cartels and other restrictive agreements: an overview
- L3: The abuse of a dominant position
- L4: Merger control in Europe
- L5: State measures and EU competition Law
- L6:State aid control

#### 2.- SEMINAR (AF2):

Seminars require prior reading and preparation of materials by the students. Seminars are conceived as dynamic and promote active participation by the students so that doubts, debate and personal opinions contribute to mature high education and critical assessment.

Resolution of hypothetical cases will compel the students to apply the ideas and concept previously developed in lectures and other seminars.

### 3. - GROUP WORKSHOP (AF3):

Six workshops will take place along the semester, all of them requiring a very active role of the students. They will have to resolve cases (both individually and in teams format), preparing short written and oral pleadings.
