I. COMMUNITY OF MADRID

C) Other Provisions

Department of Education, Youth and Sport

- 15 *ORDER 3804/2015, of December 14, of the Regional Ministry of Education, Youth and Sports, authorizing the creation and modification of centers in the Universities of the Community of Madrid.*

Article 8.2 of Organic Law 6/2001, of December 21, 2001, on Universities, establishes that the creation, modification and suppression of centers in public Universities shall be agreed upon by the corresponding Autonomous Community, either on its own initiative, with the agreement of the Governing Council of the University, or on the initiative of the University, by means of a proposal of the Governing Council, in both cases with a prior favorable report from the Social Council.

The aforementioned Organic Law establishes in its article 12.2, in relation to article 8.2, that the creation, modification and suppression of centers in private Universities will be agreed upon by the corresponding Autonomous Community, at the proposal of the University.

In accordance with the above, the Universidad Camilo José Cela proposes the change of name of four Faculties, each one of them continuing with the academic management and administrative organization of the current undergraduate and graduate studies. On the other hand, it requests the authorization of two new sites in Madrid for the teaching of the Teacher's Degrees in Early Childhood and Primary Education, as an extension of the facilities that the Faculty of Education has in Villanueva de la Cañada. The General Directorate of Infrastructures and Services of this Department has verified the compliance with the requirements of these new facilities, as regards their accessibility and suitability, in accordance with the provisions of the legislation in force, for the teaching of the official university courses and the students foreseen.

For its part, the Universidad Rey Juan Carlos, requests the creation of the Escuela de Más- teres Oficiales, which will be responsible for the academic and administrative management of the official university master's degree courses offered by the University. It also requests the authorization in Aranjuez of two new delegated teaching units of the Faculty of Legal and Social Sciences and the Faculty of Communication Sciences, for the teaching of official university studies and whose facilities will be comprised of the Antiguo Cuartel de Pavía Building, the Casa del Gobernador Building and the Lucas Jordán Building. The General Directorate of Infrastructures and Services of this Department has verified the compliance of the requirements of these new facilities, in terms of their accessibility and suitability, in accordance with the provisions of the legislation in force, for the teaching of official university studies and the students foreseen.

These proposals have been reported favorably by the University Council of the Community of Madrid at the meeting of the University Planning and Coordination Commission held on November 23, 2015, in accordance with the provisions of Law 4/1998, of April 8, 1998, on University Coordination of the Community of Madrid.

By virtue thereof, at the proposal of the Directorate General of Universities and Research, in exercise of the powers conferred by Decree 198/2015, of August 4, of the Governing Council, which establishes the organizational structure of the Regional Ministry of Education, Ju- ventude and Sport,

PROVIDED

First

1. To agree, at the request of Universidad Camilo José Cela, on the changes of name of the following centers:
 - The Faculty of Law and Economics changes its name to Faculty of Law and Economics.
 - The Faculty of Social Sciences and Education changes its name to the Faculty of Education.

The Faculty of Health Sciences changes its name to Faculty of Health. The Faculty of Communication Sciences changes its name to Faculty of Communication.

2. All the teachings assigned to the current Faculties will be understood to be assigned and will continue to be taught in their corresponding centers.

Second

1. To agree, at the request of the Universidad Camilo José Cela, to authorize the authorization of the following sites located in Madrid as an extension of the facilities of the Faculty of Education, for the teaching of the Bachelor's Degrees in Early Childhood Education and Primary Education:

- Alameda Headquarters (c/ Alameda, 14).
- Rodríguez San Pedro Headquarters (c/ Rodríguez San Pedro, 8).

2. The aforementioned facilities will be for the exclusive use of the University for the teaching of undergraduate university studies, and under no circumstances may activities be carried out in the same facilities by other non-university teaching centers. Likewise, the maximum occupancy capacity foreseen for their simultaneous use must be respected, in accordance with the Report of the General Directorate of Infrastructures and Services dated November 2.

3. Failure to comply with the provisions of the preceding paragraph shall result in the revocation of this authorization.

Third

1. To agree, at the request of the Universidad Rey Juan Carlos, to create the Escuela de Másteres Oficiales (School of Official Master's Degrees), which will be responsible for the academic and administrative management of university master's degree programs offered by the Universidad Rey Juan Carlos, either as the sole responsible party or in collaboration with other universities or national or foreign entities, leading to the awarding of official university master's degrees.

2. The School of Official Master's Degrees will be located in the Rector's Office building on the Móstoles Campus (calle Tulipán, no number).

Fourth

1. To agree, at the request of the Universidad Rey Juan Carlos, the installation in Aranjuez of two new delegated teaching units of the Faculty of Legal and Social Sciences and the Faculty of Communication Sciences for the teaching of official degree courses. The facilities will comprise the following buildings:

- Old Pavia Barracks Building.
- Governor's House Building.
- Lucas Jordán Building.

The University must respect the maximum occupancy capacity foreseen for each of the buildings in simultaneous use, in accordance with the Report of the General Directorate of Infrastructures and Services dated September 29.

Fifth

Against the present Order, which puts an end to administrative proceedings, the interested parties may file an appeal for reversal before the Regional Minister of Education, Youth and Sports within one month of its publication, or challenge it directly before the contentious-administrative jurisdictional order within two months, in accordance with the provisions of Articles 116 and 117 of Law 30/1992, of November 26, 1992, of the Legal Regime of the Public Administrations and of the Common Administrative Procedure, without prejudice to the possibility of the interested parties to file any other appeal they may deem appropriate.
